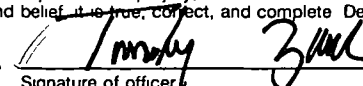

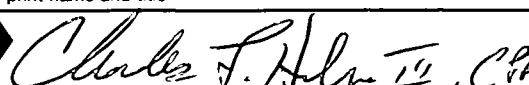

Participants' rights under the 457 Plan are equal to those of a general creditor of the Institute. The assets of the 457 Plan are held with Northwestern Mutual. The 457 Plan's asset market value was \$263,193 at December 31, 2009.

Part X - Supplemental Executive Retirement Plan -

On November 29, 2001, the Institute established a Supplemental Executive Retirement Plan for the benefit of certain members of senior management to provide deferred compensation for them upon retirement. Under the Plan, contributions are made at the discretion of the Executive Committee of the Institute until a participant reaches normal retirement age, currently 65.
