The Bill & Melinda Gates Foundation - The Gates Foundation awarded the Institute a \$1.5 million grant to comprehensively plan and implement postsecondary education programs that include the NAM-endorsed Manufacturing Skills Certification System in 4 funded colleges and states. This year the Institute executed agreements to ensure that each college had access to real-time data on occupational, employment and industry outlooks. They conducted a 2-day site visit at each college and they have employer education and engagement activities in all 4 states.

Dream It Do It - The Dream It Do It ("DIDI") campaign was started to help young adults find careers that they could be passionate about in one manufacturer's sector. This year the campaign continued to grow with the state of Connecticut joining the DIDI executive leadership team, New York expanding to a multi-county effort and considering a state-wide strategy, and Nevada considering launching the initiative. In addition the Institute hosted the 2009 fall executive leadership meeting in San Antonio.
