

The organization seeks to provide charitable aid to poor and distressed or underprivileged carpenters, joiners, related trades and occupations and their families and dependents, without regard to race, color, creed, sex or national origin. The organization also provides contributions to worthy organization's Board of Directors or their designated officers or agents, to determine whether the donation furnished is likely to aid them. The amount and nature of the aid provided is in the organization's discretion on case-by-case basis. For example, since its inception, a beneficiary of the organization's aid was a carpenter's six-year old adopted daughter who is severely handicapped born with a bilateral cleft face (without eyes, nose, mouth, palate). She has incurred at least a dozen operations since birth and will require continuing surgery and medical costs greatly exceeding the family's resources; the organization has assisted in paying the hospital and physician's bills.
