	Beyond providing accommodations and other services to retired elders, Shenandoah Valley Westminster-Canterbury (SVWC) is a responsible community member, providing meeting space for local non-profits and civic organizations and hosting community events such as the annual Westminster-Canterbury Breakfast Walk during the local Apple Blossom Festival each spring. SVWC was also pleased to host the Shenandoah Area Agency on Aging 2009 Generations Walkathon. In addition, SVWC was a sponsor of different local events, such as the Alzheimer's Association's 2009 Northern Virginia Memory Walk, First Night Winchester, and the 7th Annual Blue Ridge Hospice 5k Run/Walk. Moreover, SVWC donates medical supplies to the local Free Clinic. In the fall of 2007, SVWC began a partnership with the Shenandoah Area Agency on Aging to help deliver meals to needy seniors in the area. Since inception, nearly 5,800 meals have been delivered.
