AdoptUsKids	This program, funded through a five year cooperative agreement with the U S Department of Health and Human Services, increases the capacity of states and tribes to recruit and retain foster and adoptive parents for children who wait in foster care. Components of AdoptUsKids include training and technical assistance, a foster/adoptive parent respite initiative, the fulfillment of a national advertising campaign in conjunction with the Advertising Council, a website providing resources to both families and workers as well as a photolisting for children and families, and an evaluation component that provides feedback on all AdoptUsKids initiatives. Among its many accomplishments during the first seven years 11,703 children were placed in adoptive families, 82,627 families contacted AEA to begin the process to adopt, and training and technical assistance was provided to states and tribes throughout the country.
