Agency Summary, Program Description and Strengths:

Interfaith Council for Homeless Families of Morris County is a 501(c) not-for-profit, non sectarian organization whose mission is to prevent and end the crisis of homelessness for local children and their families. Unique in our approach, we mobilize community resources, including congregations of different faiths throughout the county to provide shelter, overnight staffing and meals to our families. This dedication and commitment of up to 1,600 individual volunteers annually makes Interfaith the most cost-effective local shelter program today. *The cost effective use of volunteers not only allows Interfaith to direct the majority of our funds to direct service, it provides a venue for community participation that is not available in a traditional shelter setting.*

We are dedicated to ending the crisis of homelessness for children and their families and single women. The shelter has the capacity to provide services to five families or fourteen individuals at one time. Created in 1988, the program is a community response to a community need and is structured to respond to the unique needs of families facing the crisis of homelessness. Over the past 20 years, paid professional staff and 1600 volunteers from more than 70 Morris County congregations have helped our community's most vulnerable families move from homelessness to permanent housing and self-sufficiency. Families gain the means with which to pull their own lives back together with dignity and hope.

In 2009, we provided 3,505 nights of shelter for 19 families and 2 single women, totaling 48 individuals, 24 of which were children. **In addition, we provided meals, case management, transportation, direct financial support, holiday assistance, and professional services for families and single women. The main goal is to transition families from homelessness to permanent housing. This program has a 88% success rate. 15 families and 1 single woaeln moved out of shelter into permanent housing. This is the key program that prepares families to live on their own and be successful in their own homes.** In shelter, families receive:

- Emergency Shelter
- 24 hr crisis intervention
- Safe, secure, home-like accommodations
- Comprehensive case management and goal development
- Life skills, parenting skills, and healthy relationship skills
- Health and educational assessment and monitoring
- Employment and housing related searches
 - Financial literacy, including budgeting, check writing, and understanding of the importance of good credit and how to maintain good credit
 - Parenting skills
 - Access to childcare
 - Food, toiletries and baby products, clothing
- A supportive environment staffed by people who care
- Information, linkage and referral
- Development of connections to community resources, organizations and individuals

Our Homelessness Education Program is a community outreach program designed to educate the community about the issues of homelessness and the societal issues facing homeless families. This program emphasizes critical thinking skills, responsibility, prevention and education. *In 2009, we conducted 20 presentations and training sessions to volunteers and the community including high schools, civic groups, youth groups and congregations.*

Our Holiday Assistance Program offers food, gifts and gift cards for both children and adults, to dozens of families who have moved out of shelter and also those in shelter. As long as the family needs assistance, they will be eligible. Several of our families are in their 6th year of this program. *In 2009, we served 30 families and single women with Holiday Assistance and gave out over 1,000 presents.*

The Permanent Supportive Housing (PSH) provides those who have successfully transitioned from shelter into their own homes with 24-hour on call support/crisis intervention services and a minimum of two years in-home case management. *In 2009, this program had a 91% success rate and served 19 families and 2 single women, totaling 65 individuals, including 39 children.*

The newly developed Tenant Based Rental Assistance Program, a new component to the PSH Program, created a partnership with community agencies and local government to offer a housing voucher to 2 of our families. *In 2009, 2 families received a housing voucher and ongoing case management of at least 3 hours a week to help them maintain their housing!*

Community involvement and organizing - are important to effect change on a greater level. For the past 3 years, we have organized an event for the homeless in Morris County - Project Homeless Connect. PHC is a 1-day, 1-stop event to provide actual tangibles and referrals to the homeless in the community who do not seek services due to fear, anxiety and many other reasons. In 2009, we transitioned this event to a larger agency after 4 years of organizing the event.
