Patient Services. Promotes holistic wellness through health promotion and education, assistance with WIC enrollment, chronic disease management, and programmatic support. Mary's Center provides on demand and off site HIV and pregnancy screening, as well as a comprehensive set of counseling services and educational programs related to nutrition, disease prevention, and other health related topics. The Center's staff delivers such programs using effective academic methodologies that are based on community focused practices. Services are provided to families in communities that are challenging to access through the outreach of a mobile van.

Social and Educational Services. Mary's Center implements a holistic approach to health care and recognizes that, in addition to ensuring the physical health of our families, we must also work to ensure their social and emotional health. Stressors that impact social and emotional health can adversely impact an individual's ability to access services and/or contribute to somatic concerns that necessitate medical visits. To address these issues, Mary's Center offers a wide range of wrap around services, including on site case management, after school adolescent education and supportive services, in home visits to families and their children and parental educational services.

Medical Services. Include the provision of prenatal and postnatal care for pregnant women and babies, pediatric care for children, and primary care for teens, women, and men. Our primary care services include physical exams, family planning, vaccinations, and chronic illness medical management. Our bilingual mental health services include diagnosis, assessment, counseling, case management, and prescription and monitoring of somatic medications. Substance abuse screening, referrals, and post-detox counseling are also available.
