Advocacy for Greater Investment in Research for Health. Investing in research yields both short-term and long-term economic gains and improves the health of Americans. Research!America leads the way to ensure robust, increased investment in the National Institutes of Health, Centers for Disease Control and Prevention, Agency for Healthcare Research and Quality, and National Science Foundation. We promote policies that foster innovation to help the U.S. maintain its competitive edge in medical and health research. In support of our mission, Research!America conducted more than 100 meetings in 2009 with Members of Congress and their staffs, issued nearly 30 action alerts to our grassroots network, and led or were part of 15 congressional briefings and 20 statements and letters to Congress.

Paul G. Rogers Society for Global Health Research. Named for The Honorable Paul G. A distinguished Advisory Council selects the Rogers Society Ambassadors. The 75 Ambassadors increase awareness of-and make the case for-greater U.S. investment in research to fight diseases that disproportionately affects the world's poorest nations. In consultation with Research!America, they engage policy makers, thought leaders and the media on the value and importance of global health research.

Forums and Partner Programs. Research!America's 2009 National Forum provided an opportunity for an interactive discussion of the value of medical and health research and ways to enhance its impact. Research Partners Forums are open dialogues between leaders in academia, business, government, non-profits and the public on subjects relevant to improving health through research. Our forums generate discussion about the social and economic impacts of research at the intersection of science, public policy and politics. Our 2009 partners programs included more than a dozen events on Capitol Hill that facilitated dialogues among leaders in academia, business, non-profits, the public, and Members of Congress and their staffs on subjects related to improving health through research.
