To prepare public & charter school students from at-risk communities in the Washington, DC area to enter college, earn a degree & achieve their professional goals. Accomplishes its mission by providing sustained tutoring, mentoring & college preparatory enrichment activities to approx 150 students in its Academic Mentoring Program & an additional 250 students through its outreach activities. Flagship Academic Mentoring Program pairs individual students with adult volunteers from a wide array of careers & professions for weekly mentoring activities at designated sites around Washington, DC

TUTORING & COLLEGE PREPARATION ASSISTANCE AND MENTORING The components of the Organization's college preparation and scholarships program include academic mentoring, writing workshops, SAT/ACT preparation, college tours, a college fair, and a career night. For its flagship Academic Mentoring Program, students from at-risk communities and adult volunteer mentors from a vast array of careers and professions meet once per week for two hours or more at one of five community-based sites - Beacon House, Cesar Chavez Public Charter School, Gonzaga High School, Sherwood Recreation Center and the campus of BET Networks. A virtual mentoring component was recently added as an extension to the Organization's successful Academic Mentoring Program. Over and above assistance with the completion of coursework, each student's virtual mentor is a resource for college coaching, college transition support, and assistance with obtaining internships. Through writing workshops, volunteer writing coaches help students develop the skills needed for college applications and financial scholarships. A College Exploration Day was launched to increase the number of outreach students around the city and provide early exposure to a college-going culture. This experience provided an additional 250 eighth grade students across the city the opportunity to interact with professionals representing an array of colleges and career fields. The Organization also provides drop-in services to both students and recent graduates who are not enrolled in the academic mentoring program to help them obtain their goal of a post secondary education. These services are available Monday through Friday by appointment in the Organization's main office. In stark contrast to the performance of Washington, DC schools, where less than 50 percent of students entering high school eventually graduate, the Organization has a proven track record of success for students in terms of academic performance and entrance to institutions of higher education. In 2009, 100 percent of the seniors enrolled in the Organization's program graduated from high school, and 100 percent of these students are currently enrolled in college.

ACADEMIC SCHOLARSHIPS TO ASSIST STUDENTS WITH FUNDING THEIR EDUCATION, THE ORGANIZATION OFFERS A SCHOLARSHIP PROGRAM. TWELVE ANNUAL SCHOLARSHIPS ARE AWARDED, RANGING FROM \$1,000 TO \$12,000, TOWARD THE COLLEGE EDUCATION OF COLLEGE PREPARATION JUNIORS AND SENIORS. THESE SCHOLARSHIPS HELP CLOSE THE GAP BETWEEN THE FINANCIAL AID A STUDENT RECEIVES FROM COLLEGE AND THE ACTUAL COST OF ATTENDING. TEN \$6,000 SCHOLARSHIPS AND TWO \$1,000 SCHOLARSHIPS WERE AWARDED IN 2009.
