UTAM is a non profit corporation formed to serve as the frequency coordinator for the unlicensed personal communications services (UPCS) industry. UTAM's role as frequency coordinator changed in 2005 to one of insuring that all manufacturers of products for the upcs spectrum band pay their fair share of the financial obligations incurred by UTAM in the course of clearing the band. UTAM's coordination role will end and the Company will be dissolved when the costs of microwave relocation are fully recovered.
