MONITORING AND LOBBYING NON-TARGETED STATE LEGISLATURES Monitored all marijuana-related bills in the 50 states and the District of Columbia, published information on these bills on 51 state Web pages, issued state-specific email alerts to supporters of marijuana policy reform, and assisted with the drafting of legislation in a handful of states

GRANTS PROGRAM Reviewed proposals from outside individuals and organizations and issued 12 grants to (1) orchestrate grassroots and direct lobbying in Illinois, Massachusetts, Montana, New Hampshire, North Carolina, Rhode Island, and Vermont, (2) organize college students and supportive clergy nationwide, (3) pass local ballot initiatives in Colorado and Idaho, and (4) place a medical marijuana initiative on the statewide ballot in Oregon in November 2010

FEDERAL LOBBYING Monitored all marijuana-related bills in Congress and lobbied Congress to (1) defeat all bad marijuana-related legislation, (2) reduce the advertising budget of the White House Office of National Drug Control Policy, (3) increase the level of support for medical marijuana legislation, (4) build support for the introduction of legislation to end marijuana prohibition entirely on the federal level, (5) repeal the federal prohibition on making medical marijuana legal locally in the District of Columbia, and (6) generate congressional pressure on the Obama administration to issue a new policy to de-prioritize the federal prosecution of medical marijuana offenses in states where medical marijuana is legal

NEW HAMPSHIRE LOBBYING Lobbied the New Hampshire legislature to pass medical marijuana legislation MPP succeeded in putting the bill on the desk of Gov John Lynch (D), who vetoed the bill The House then overrode his veto by exceeding the necessary two-thirds supermajority, but the Senate failed to override the veto by a mere two votes

MINNESOTA LOBBYING Lobbied the Minnesota legislature to pass legislation to (1) allow patients to use, possess, and grow their own marijuana for medical purposes, and (2) authorize nonprofit dispensaries to sell marijuana to patients The legislature passed a watered-down version of the bill, only to see it vetoed by Gov Tim Pawlenty (R)

ILLINOIS LOBBYING Lobbied the Illinois legislature to pass legislation to (1) allow patients to use, possess, and grow their own marijuana for medical purposes, and (2) authorize nonprofit dispensaries to sell marijuana to patients The bill passed the state Senate by the exact number of votes that were needed to pass, as well as the key committee on the House side The bill was left pending on the House floor until the legislature reconvenes in 2010

NEW YORK LOBBYING Lobbied the New York legislature to pass legislation to (1) allow patients to use, possess, and grow their own marijuana for medical purposes, and (2) authorize nonprofit dispensaries to sell marijuana to patients

NEVADA BALLOT INITIATIVE Took preliminary steps to launch a campaign to pass a statewide ballot initiative to tax and regulate marijuana like alcohol in November 2012

CALIFORNIA LOBBYING Lobbied the California legislature to (1) pass legislation to tax and regulate marijuana like alcohol, and (2) build support for future legislation to create a state-licensing system for medical marijuana dispensaries and their growers Also, on the local level, continued lobbying county by county to implement the 2003 state law (S B 420) that requires counties to issue medical marijuana ID cards to qualified patients

PUBLIC EDUCATION Did media interviews, updated the Web site, and produced hard-copy newsletters to (1) educate the public and MPP’s dues-paying members, (2) increase public support for ending marijuana prohibition, and (3) maintain public support for legalizing medical marijuana

MASSACHUSETTS LOBBYING Began lobbying the Massachusetts legislature to pass medical marijuana legislation

VERMONT LOBBYING Lobbied the Vermont legislature to pass a marijuana decriminalization bill, as well as a medical marijuana dispensary bill (to expand on the medical marijuana law that MPP enacted in Vermont in 2004)

RHODE ISLAND LOBBYING Lobbied the Rhode Island legislature to expand on the state’s medical marijuana law in order to allow for the creation of nonprofit dispensaries to sell medical marijuana to patients The legislation passed, Gov Donald Carcieri (R) vetoed it, and the legislature overrode his veto -- marking the third time that an MPP-sponsored medical marijuana bill was enacted into law over the veto of Gov Carcieri
