

MISSION STATEMENT

Our mission statement has remained the same since our inception in 1997: to improve the research on childhood illnesses in a medical environment that concentrates on lowering cost while improving patient outcomes.

Reduced Medicare funding by Congress has translated to reduced HMO funding at all levels. The state of Medical care, hospitals, teaching of new doctors in America is getting worse. Existing medical payments has changed the way medicine is delivered, administered and practiced. To complicate the situation, the extent of the acute nature of the problem is recognized by few outside the medical community. In addition, the far reaching implications of the issues are not clearly recognized or understood by the general public.

One implication, the patient doctor contact in the office visit is limited to 7 minutes; further, by nature of patient payments the management of the patients illness has been shifted from the doctor to the patient and his family.

The limit of doctor and patient contact is grossly inadequate for patient welfare, especially when chronic pathologies require constant monitoring, constant education and constant review. Our present system discourages, in fact, prohibits that which is required for minimal good medicine.

Another implication is the effect congressional budget cuts have had on the curtailing of medical research and the diminution in the quality of Resident training.

These and other factors create an egregious diminution in the quality of the American medical system, with no end in sight.

The John Francis Foundation intends to devote much of its funds to address these issues, understand their implications and experiment with creative methods to address the problems created.

Over the years we have developed sophisticated tools to further help:

Clinical outcomes

Community Outreach

Research & Education

We have relied not only on our yearly contributions but on the volunteering of Doctors specialist and practitioners who have given generously of their time and talent. Without them our program which has been highly successful programs would be a skeleton of its present state.

We have had an effect on:

Scoliosis

Downs Syndrome

Cerebral Palsy

Club Feet

Hip Dysplasia

Perthes Disease

Bone & Joint Infection

Bone & Joint Tumors

We have spent \$11,000 (specially built) on a machine (specially built) to test the tensile strength of pins used to treat fractures. We have purchased Cadaver Cut Bones and with the assistance of Allegheny Research continue with this special research.

In conjunction with St Vincent College, we over an extended period of time (ongoing over many years) have worked on a highly specialized Computer Program research project that provides highly valuable tools for families to manage their child's disorder (Muscular Skeletal Disability).

Involvement in the research program includes volunteer Doctors, 4 St Vincent's students and a Professor.

"To provide for research & development of new surgical techniques that can be applied more non-invasively using cutting edge special imaging technology".

Through a grant from our foundation we continue to support the "Children Musculoskeletal Motion Program". This is the first program of its kind to address the prevention of sequelae hip joint disease in children, using a multi-disciplinary approach.

We continue to focus on our program with Legg-Calve-Perthes Disease affecting the hip in children. Perthes Disease affects otherwise normal children and its etiology is unknown. Children who have Perthes Disease of the hip are 10 times more likely to develop more severe forms of this disease when they become adults. Forty per cent of all children with Perthes Disease will require hip joint replacements as adults (McAndrews and Weinstein)

We continue to offer as free services:

- > An expanded in-office learning center for patient and family education.

- > An on-line web site to monitor and document hip joint function and to provide feedback for patients, pediatricians and orthopaedic surgeons.

A sample of the service we offer the community is an in-office center where special presentations are given to patients contemplating surgery. Approximately 400+ presentations are made every year by volunteer Doctors and material developed by our Foundation.

In addition, we offer a center that is open 8 hours a day and manned by Foundation personnel. A significant number of medical community telephone calls (ranging in thousands per year) are answered because of Foundation documents and personnel.
