The program supports both established policy thinkers, and those who have exceptional potential but are not yet well established. All come to New America to pursue solutions-oriented research and writing projects of their own design.

The Fellows Programs wrote 332 articles and policy papers, held 27 public policy events and had 298 media appearances.
