Retail Program Goodwill of Greater Washington's retail stores and donation centers are central to the fulfillment of goodwill's mission to provide jobs, job training and employment services for people with disadvantages and disabilities In 2009, over \$13 million worth of gently used clothing, furniture, and other household goods were sorted, priced and sold in goodwill's nine retail locations, saving our customers hundreds of thousands of dollars on quality, low cost goods, while providing the revenue necessary to fund our critical job training programs In 2009, over 700,000 transactions were made and some 300,000 people generously donated these goods, keeping over 422 tons of donated goods out of area landfills Most computers are now recycled through the Dell Reconnect Program resulting in the reuse of virtually every part and component In 2009, Goodwill of Greater Washington recycled over 500,000 pounds of computers and computer parts Goodwill stores are also a source of mission fulfillment We don't just provide job training to people with barriers to employment we also employ them Many of Goodwill's 215 retail employees have overcome significant challenges and obstacles to find success in their work

Contracts one of Goodwill of Greater Washington's most successful business and mission fulfillment operations is its contract services division In 2009, under the Ability One program, Goodwill employed almost 240 people in its 24 contract sites throughout the DC area including the Bureau of Engraving & Printing, the National Gallery of Art, the Old Post Office Pavilion, Bolling Air Force Base and the Army Research Lab More than 75% of Goodwill of Greater Washington's contract employees suffer from a severe disability By providing custodial, grounds maintenance, and pest control services to government and commercial facilities, Goodwill offers their employees hope, dignity, and a future for themselves and their families Goodwill is all about people working We are one of the Washington, DC area's largest providers of employment and training services for people with disabilities and other barriers to employment We believe in work Work helps build self-confidence, friendship, independence, dignity and trust Everyone deserves a chance to have these things in life Goodwill provides that chance

Training and employment in 2009, Goodwill of Greater Washington provided job training, employment and other supportive services to over 3,000 people in and around our nation's capital These critical services were funded through the revenue generated by goodwill's contract operations as well as from the donations sold at Goodwill's nine area retail stores, in addition to the generous financial support of our individual and corporate donors As the region continued through one of the worst recessions in American history, the population of people seeking Goodwill's help began growing in large numbers and coming from all walks of life The populations Goodwill serves are very diverse and face a variety of barriers to employment They may have physical, emotional, developmental or other disabling conditions, or they may lack an education or English proficiency Many of the people Goodwill serves are ex-offenders trying to rebuild their lives The one consistent barrier faced by all of the people who walk through Goodwill's doors is a lack of marketable job skills That's why the training and employment division provides employability skills training (job readiness), job placement, occupational skills training, job coaching, and/or retention services These skills will help individuals with disadvantages and disabilities enter or re-enter the workplace with confidence and dignity Our primary goal is to match the skills, interests, and work preferences of our students to the needs of local employers This is accomplished through an individualized employment plan, interviews, career assessment, internships, work trials, and other discovery strategies In 2009 Goodwill offered its applicants several different job training options Environmental services, bank skills, career navigation, or green construction pre-apprenticeship training Goodwill has expanded and retooled its existing training programs in order to respond to community needs and industry trends In 2009 Goodwill partnered with the Green Builders Council of DC to add training and certification in sustainable building, weatherization, and smart meter installation to our construction pre-apprenticeship program The program re-launched in June 2009 as Green Pathway DC This is a part of an overall green movement within Goodwill that started in early 2008, when we began adding instruction in green commercial cleaning techniques to the environmental services program in order to teach students the most current industry standards and prepare them for the emerging green cleaning market Green initiatives are not new to Goodwill The charitable agency is often referred to as the original recycler, since it has been reusing and recycling donated goods here in our nation's capital since 1935 through its retail operations
