THE PLANT CELL PUBLISHES CUTTING-EDGE RESEARCH PAPERS IN CELLULAR MOLECULAR, AND DEVELOPMENTAL BIOLOGY OF PLANTS. ASPB ALSO PUBLISHES A BI-MONTHLY NEWSLETTER (ASPB NEWS) ON GENERAL NEWS ITEMS ON THE SOCIETY AND THE INDUSTRY AND SEVERAL OTHER SMALLER BOOKS AND PAMPHLETS ON VARIOUS SPECIFIC TOPICS WITHIN THE PLANT BIOLOGY PHYSIOLOGY INDUSTRY.
