Provisions related to Emeritus and Honorary Trustees were moved to the Bylaws. BYLAWS. Emeritus Trustees are limited to two consecutive three year terms, making their terms consistent with Trustee terms. No limit is placed for Honorary Trustees. Neither Emeritus nor Honorary Trustees are allowed to vote. Executive committee-In lieu of a Treasurer, which is not required under the Virginia Nonstock Corporation Act, the Chair of the Finance Committee now serves on the Executive Committee with the Chair, Vice Chair and Secretary, and the remaining members of the Executive Committee are nominated by the Nominations and Governance Committee and elected by the full Board. The Executive Committee's powers and responsibilities have been modified as follows --its actions are no longer reviewed for ratification by the full Board but merely reported to the full Board, clarifying its power to act in lieu of the Board --its power to remove the President and elect the Audit Committee has been removed and reserved to the full Board --it has the added responsibility of conducting performance reviews for the President and compensation reviews for officers and staff reporting directly to the President (e.g. the Executive Vice President and the Vice President/CFO), and is no longer required to meet monthly, but only as needed. The role of the Nominations and Governance Committee has been expanded to include development of governance principles based on best practices. Committee chairs are appointed by the Board Chair, and the Board Chair may also appoint Emeritus Trustees and non-Trustees to the committees (except for the Audit and Finance Committees), but they may not vote or be appointed as chairs of committees.
