We hold a limited partnership interest in Eastern American Energy Corporation, left to us many years ago under the terms of a will. Before it became Eastern Energy, it was in bankruptcy. In early 1994, we contacted Eastern to find if our interest had any sales value. A written response was received indicating an error on their part and checks totaling \$10,976.00 were received, which covered income that had not been disbursed for a number of years. No information on valuation was received. Checks totaling \$772.24 were received in 1996, \$853.00 in 1997, \$678.03 in 1998, \$789.00 in 1999, \$1,432.50 in 2000, \$763.18 in 2001,

\$597.62 in 2002, \$1,780.37 in 2003, \$1,302.63 in 2004, \$1,024.10 in 2005, \$1,261.85 in 2006, \$1,750.00 in 2007, \$2,257.60 in 2008, and \$747.71 in 2009. We still have no information as to value.

Our accounts are not audited as separate accounts. Accounts S-9, S-10, S-21, S-25, S-34, S-54, S-83, and S-104 are invested in The Southern Virginia Diocesan Foundation of The Episcopal Diocese of Southern Virginia. The Trust Department of Bank of America in Richmond, Virginia manages this fund. The Bank's accounts are audited and we feel this is sufficient. Monies received are forwarded quarterly to the Diocese with deposit instructions. Expense monies for maintenance and preservation of our church properties are withdrawn from S-34 (Income Account) quarterly and disbursed as approved by our Endowment Fund Board. One-half of the income of S-9, S-10, S-21, S-25, S-54, S-83, and S-104 is transferred to S-34 (Income Account) quarterly and the other is reinvested in the respective fund(s).

The Lafayette and Lucille Williams Fund is a fund created by a bequest for mission/outreach activities. Its corpus is held and managed by Wells Fargo Advisors, LLC. This account is audited, and we feel this is sufficient. This Fund distributes one-half of the income, and the other half is reinvested in the corpus.
