During 2009 the Kirov Academy graduated 11 students with a high school diploma. The student body for the academic year ending in May 2009 consisted of 69 students, while the enrollment as of September 2009 was 77 students. Approximately 800 dancers were auditioned during a six week audition tour early in the year that included 12 different cities in the United States. Many of these were selected to attend intensive training sessions held in the summer at the Kirov Academy. Total enrollment for the summer sessions was 300 students. The school also staged concerts which were held in our studios in May and December for the sake of parents and invited guests.
