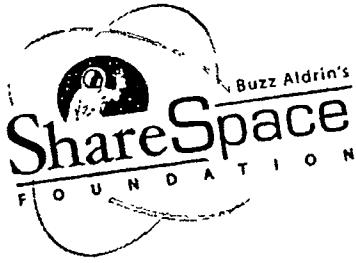

STATEMENT OF PROGRAMS, SERVICES AND ACCOMPLISHMENTS ~ FOR THE YEAR 2009 ~

During the 2009 celebration of the 40th Anniversary of the Apollo 11 moon landing, ShareSpace Foundation and its Chairman Buzz Aldrin pushed forward the "Lunar Renaissance" initiative to raise public awareness and enthusiasm for America's space program. Specifically, ShareSpace and Buzz Aldrin partnered with the AIAA to present a panel discussion "From Apollo XI to the First Humans on Mars" at the California Science Center to a live audience that included aerospace industry professionals to general space enthusiasts and young budding astronomers. The six panelists included astronaut Buzz Aldrin, and space experts Albion Bowers (strategic planner for NASA's Aeronautics Mission Directorate's Environmentally Responsible Aviation), Michael Sander (leader of JPL's efforts in support of the new NASA Exploration Initiative), John Stammreich (VP, Global Strategy, Network and Space Systems for Boeing Integrated Defense Systems), Thomas Taverny (Senior VP, Science Applications Corporation), and Hal Walker (manager for the testing of the Apollo 11 lunar ranging laser experiment). The lively discussion was moderated by Howard McCurdy (Professor, School of Public Affairs at American University).

Also in furtherance of the Lunar Renaissance initiative, Dr. Aldrin shared his insights at the Google Lunar X Prize media launch to encourage private exploration efforts of the moon held in Washington, DC on July 20, 2009.

Dr. Buzz Aldrin represented ShareSpace in personal appearances to promote space and science education to students at CENIC (Corporation for Education Network Initiatives in California) with educator Dick Ballootian, STEP (Science and Education Technology Education Partnership) with Congressman Calvert in Riverside, CA, and is currently serving as Honorary Chairman for the development of a space and science education facility to be developed by the California Space Authority in the vicinity of Vandenberg Air Force Base in the Central Valley of California. In addition, Dr. Buzz Aldrin represented ShareSpace in a special space education video conference with students in Uruguay organized by former U.S. Ambassador to Uruguay, Frank Baxter.

ShareSpace continued to research ways in which to invigorate public support and awareness for America's space program and develop programs to involve the public in privatized space travel opportunities through prize-based programs, contests and games, and TV reality programs.
