**Organizational support to Marie Stopes International for expanding delivery of global family planning services**  
**Services were provided to 6.3 million clients in 2009, generating 18 million Couple Years of Protection (CYP's ), 33% more than in 2008 at an average cost of \$2.67 per CYP. Globally Marie Stopes International provided long term and permanent contraception to approximately 1.7 million men and women during the year, a 42% increase on 2008.**

**Organizational support to Marie Stopes International for expanding delivery of family planning services in Africa**  
**In 2009, MSI provided more than 10% of all modern contraception in six African countries: Malawi (40%), Sierra Leone (39%), Tanzania (24%), Uganda (20%), Kenya (15%) and Madagascar (12%). New operations were started in Sudan and Nigeria. In Ethiopia MSI services generated 433,085 CYPs, equivalent to averting 131,049 unsafe abortions.**
