IT BEGAN AS AN UMBRELLA ORGANIZATION FOR THE MASTERS OF FOXHOUNDS EDUCATIONAL FOUNDATION AND HUNTS STAFF BENEFIT FOUNDATION, BOTH 501(C)(3) ORGANIZATIONS. IT IS SUPPORTED BY 6 VOLUNTEER DIRECTORS AND ONE EXECUTIVE DIRECTOR. THERE ARE THREE OFFICERS CHOSEN FROM THIS CADRE.

THE MFHA FOUNDATION'S MISSION WAS TO ALLOW CONTRIBUTIONS FROM PEOPLE WHO ARE UNSURE TO WHICH OF THE OTHER TWO FOUNDATIONS THE MONEY IS GIVEN. IT ALLOWS THEM TO SEND ONE CHECK. UNLESS THE DONOR IS SPECIFIC AS TO WHICH FOUNDATION THEY WISH TO CONTRIBUTE, THE MFHA FOUNDATION DETERMINES THE AMOUNT OF MONEY EACH OF THE FOUNDATIONS RECEIVES OR MAY GIVE THE ENTIRE AMOUNT TO THE MOST NEEDY FOUNDATION.
