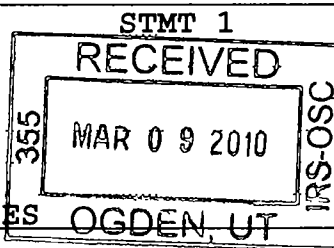

FACTS AND CIRCUMSTANCES

THE CURRENT YEAR IS THE ORGANIZATION'S SEVENTH YEAR. DURING ITS EARLY YEARS, CCN HISTORIC BUILDING PRESERVATION FOUNDATION ("THE FOUNDATION") RECEIVED CERTAIN UNUSUALLY LARGE CONTRIBUTIONS THAT DID NOT QUALIFY AS UNUSUAL GRANTS. THE FOUNDATION IS THEREFORE UNABLE TO MEET THE ONE-THIRD SUPPORT TEST ON THE BASIS OF SUPPORT RECEIVED DURING THE FIVE YEAR PERIOD COVERED BY THE SUPPORT TEST. HOWEVER, THE FOUNDATION DOES MEET THE FACTS AND CIRCUMSTANCES TEST ON THE BASIS OF THOSE YEARS.

FIRST, THE FOUNDATION MEETS THE TEN-PERCENT-OF SUPPORT REQUIREMENT. THE FOUNDATION'S PUBLIC SUPPORT PERCENTAGE IS 31.54% FOR 2009 AND 33.14% FOR 2008, WHICH ARE FAR GREATER THAN THE REQUIRED 10% AND ALMOST MEET THE ONE-THIRD TEST.

SECOND, THE FOUNDATION MEETS THE ATTRACTION OF PUBLIC SUPPORT REQUIREMENT. THE FOUNDATION IS LESS THAN SEVEN YEARS OLD AND HAS, IN ITS EARLY YEARS, SOLICITED PERSONS WHO WOULD BE MOST LIKELY TO PROVIDE SEED MONEY SUFFICIENT TO ENABLE IT TO BEGIN ITS CHARITABLE ACTIVITIES AND EXPAND ITS SOLICITATION PROGRAM. THE SCOPE OF ITS FUNDRAISING ACTIVITIES ARE REASONABLE IN LIGHT OF ITS CHARITABLE ACTIVITIES, WHICH ARE LIMITED TO A SPECIAL FIELD THAT CAN BE EXPECTED TO APPEAL TO A LIMITED NUMBER OF PERSONS, PRIMARILY IN THE LOCAL COMMUNITY.

FINALLY, THE FOUNDATION IS IN THE NATURE OF A PUBLICLY-SUPPORTED ORGANIZATION, TAKING INTO ACCOUNT THE FOLLOWING FACTORS. THE FOUNDATION'S PUBLIC SUPPORT PERCENTAGE OF 31.54% FOR 2009 AND 33.14% FOR 2008 ALMOST
