Services provided by the hospital included 1,382 inpatient days of care, 20,850 outpatient visits, 11,514 emergency room visits, 3,920 home health visits and 7,498 clinic visits. Charges forgone for charity care amounted to \$98,404. The hospital is designated as a critical access hospital and serves a mountainous, rural area of West Virginia.

The tuition plan is designed to encourage participation in courses offered by an accredited two (2) or four (4) year state-supported college or university. The plan applies only to tuition and books. All course work must relate to the employee's current position or a future position needed within the hospital. Employees who have completed one year of continuous employment working at least 20 hours per week are eligible to apply. Employees who receive assistance under this plan must remain employed after the completion of the course of study for an amount of time equal to the time during which tuition reimbursement was received.

The hospital serves as an educational site for the West Virginia Rural Health Education Program (RHEP). We provide office space, conference rooms and student rotations for this program. Through this program, 183 medical, dental, pharmacy and nursing students were placed in educational rotations. Of this number, 24 were directly placed in Braxton County. This program also offers cardiac kids, a health screening program for elementary students throughout north central West Virginia. Last year, 17,220 community members in a five-county region participated in these various screenings and projects.

Services provided by the hospital included 1,382 inpatient days of care, 20,850 outpatient visits, 11,514 emergency room visits, 3,920 home health visits and 7,498 clinic visits. The hospital is designated as a critical access hospital and services a mountainous rural area of West Virginia. Our geographic area is primarily Braxton County with portions of the surrounding counties, Nicholas, Clay, Webster, Lewis and Gilmer. Braxton County's population is approximately 14,000 with Nicholas at 26,000, Clay- 10,000, Webster - 9,000, Lewis - 17,000 and Gilmer - 7,000. The average income is \$21,000 for Braxton County. Braxton County Memorial Hospital is the only hospital in our community servicing the needs of the residents. Braxton County is also federally designated as an HPSA (Health Professional Shortage Area).
