The hospitals supported are Ohio Valley Medical Center, Inc and East Ohio Regional Hospital at Martins Ferry. The Foundation awarded scholarships to nursing students in 2006 to assist with their tuition, books and fees at West Liberty State College. The awards were based on financial need of academically outstanding students.
