WV United Health System Procurement provides integrated purchasing services for the four System hospitals. The contracting unit of the dept. manages the health systems supply chain contract portfolio to assure that the system wide spending volume is leveraged to achieve best in class pricing and terms for supply chain contracts. The operations unit of the dept. provides front line customer service and processes daily purchase orders to assure an uninterrupted flow of products needed to support patient care. During 2009, the aggregate amount of savings realized by the four WV United Health Systems Hospitals totaled 2,654,356

In 2008 WVUHS created an in-house collection department designed to provide services to system hospitals and subsidiaries, and to supervise outside firms contracted for collection services. By implementing collections on a System level, we want to increase collections while lowering collection costs. In addition, WV United Health System hopes to have its members utilize uniform collection practices designed to be more effective and cost efficient

WVUHS coordinates inter-hospital efforts to ensure clinical quality and meet improvements parameters established by government agencies and national health care organizations. Both WVU Hospital and United Hospital Center were among the original participants in the Center for Medicare Services CMS/Premier Hospital Quality Initiative pilot program, which just completed its sixth and final year as a pilot program prior to full implementation. All WVUHS hospitals participate in the CMS Hospital Compare initiative, designed to provide consumers with comparative clinical results to aid them in their selection of a hospital for care. Similarly all WVUHS facilities participate in the HCAHPS initiative, designed to provide patients with comparable patient satisfactions scores among hospitals

In 2004, WVUHS hospitals purchased Patient Business Folder software, which is an optical imaging software, this allows physicians and other hospital staff to access patient records immediately and more cost effectively than with the existing paper records.
