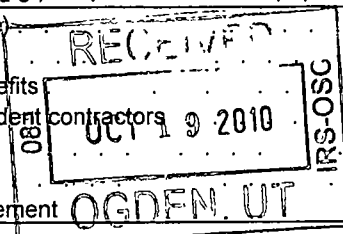

Organization's Primary Exempt Purpose

Childlaw Services, Inc., (CLS), a nonprofit corporation provides a voice for children through legal representation, policy advocacy, and development when such children are involved in legal proceedings relating to abuse or neglect, are victims of crime, or subjected to protracted custody disputes.
