The matches recognize the accomplishments of the student athletes and our member coaches from universities and colleges throughout the United States. Additionally the matches provide the opportunity for junior golfers to receive instruction from the student-athlete participants and coaches.

National Copaches Convention - the event is held annually for the membership and invited guests to discuss pertinent issues and topics related to collegiate golf. Numerous educational breakout sessions are held to provide professional development and education to the membership. Nationally significant speakers provide education during the convention. A National Awards and Hall of Fame Banquet is held during the event to recognize the outstanding achievements of selected member coaches.
