Campers are exposed to biblical principals & outdoor activities by our trained counselors & volunteer ministers. Campers meet with the pastor once a week, say grace at every meal, have daily devotions, and are taught morals & biblical principals through stories, songs, games & activities. Outdoor activities include swim canoes, paddleboats, diving, ziplines, low & high ropes courses, bouldering wall, climbing tower, hiking, rock climbing, whitewater rafting, backpacking, tubing, fishing, mountain boarding, horseback riding, etc.
