China Working in concert with the Chinese government, a child's right worked in 115 orphanages in 8 provinces providing over 18,000 children clean water. The majority of these sites also house elderly care facilities so secondary clean water solutions were provided to over 9,000 adults

Cambodia The Cambodia program worked with 20 sites providing 43,957 children and 4,256 adults clean water. Sites ranged from rescue homes for sexually trafficked children housing 50 girls and women all the way to the country's largest pediatric hospital which serves more than 120,000 children annually

Nepal 35,672 children and 882 adults were provided with clean water through working with 6 schools and the country's largest pediatric hospital, which provides care for more than 130,000 children annually. Ethiopia Ten projects at orphanages, street shelters, schools, and clinics, served 5,062 children and 1,378 adults with clean water. This included working at the Mother Teresa mission- the organization's largest project in Ethiopia and working at HOPE Enterprises street shelter which provides more than 200,000 meals to street children annually. All of them now have access to clean water daily
