Part II

As we are on a cash basis, have no capital, no liabilities and no assets other than cash, we do not prepare a balance sheet.

Line 26. Our fiscal year runs from July 1, 2009 to June 30, 2010. Dues for the next FY are collected in April/May/June of the previous year and are treated as Deferred Income until July 1 in order to accurately match revenues and expenses for each fiscal year. Column B. \$57150 contains dues of \$50,450 and member contributions of \$6700.

Part III

Affiliated with the World Affairs Council of America, the purpose of the 450 member WACHH is to inform and to educate its members and the wider community about foreign policy issues.

To accomplish these objectives WACHH has two programs. Speakers and Educational Outreach.

The Speakers Program meets twice a month from October until May and offers WACHH members an extensive program on foreign affairs, economic and national security issues through presentations by foreign affairs practitioners, academicians, government, business and military leaders. In the FY under review, we conducted 15 such presentations. Attendance at each presentation usually exceeds 200 and meets capacity of our venue. Direct costs attributable to the Speakers Program during this period were \$19,205 about 53% of Total Expenses.

Educational Outreach has two elements.

The first is the High School effort in which volunteer members of WACHH conduct presentations and lead foreign affairs discussion groups at two local high schools. Next year we plan to serve two more high schools. In the last FY, 15 such programs were offered. WACHH has no direct costs associated with this effort.

The second element of Educational Outreach is our summer program which consists of three separate presentations on foreign policy related issues made by a volunteer member of WACHH. These are open to members and non-members alike. Attendance at each presentation is usually about 100. Direct costs associated with this effort were \$457.
