Award winning sculptors from across the nation participate in the event each year. 90% of surveyed visitors say that they learned something new about sculpture. Special youth oriented hands-on workshops continued. Walking tours of the Summerville Permanent Public Sculpture Collection are given during the event, further educating attendees of the importance of public art and the mission of the organization. Over 20,000 show & sale rack cards and brochures are distributed annual to art enthusiasts and visitors of both Summerville and South Carolina.
