The ministry's largest single project of the year is collecting presents for individuals in local nursing homes and for individuals with disabilities and special needs. We have undertaken this project for a number of years, and this is what we are known for in the community. This large single project includes collecting Christmas presents from the local community to present to those in need. We are in a small town in a rural county in South Carolina. We collect presents for hundreds of people served by the Chesterfield County Board of Disabilities and Special Needs. Also we collect presents for those who are without necessities in local nursing homes and residential care facilities.

The items requested are items such as socks, underwear, toiletries, shoes, clothes, and other necessities. Many of the residents also request radios, CD players, and CDs as the facilities in general only have a few TVs in public areas. Many of the residents in the nursing homes and residential care facilities have very little personal possessions and do not have family taking care of their needs. Staff at the Board of Disabilities, nursing homes, and residential care facilities ask the individuals what they are in need of most.

Each person, in general, requests three (3) or more necessities. It has been the local community who has met these needs through our collection process. Volunteers speak to local civic organizations, business organizations, and local churches and request that they buy necessities for these individuals. They ask that new items are purchased. These individuals bring to their organization, club, or church the presents they have. We collect the gifts with the individuals' names on them and in turn they are given to the elderly and disabled. In total, we collect presents for approximately 400 people with the Board of

Disabilities, at local nursing homes, and residential care facilities. We also place gift trees at different locations. The gift trees have the name of an individual in need and the items they need. These trees have been placed in locations such as local branches of national banks, local branches of South Carolina banks, local stores for national retailers and national food store chains, the Chesterfield County Board of Disabilities' office, beauty salons, restaurants, doctor's offices, fast food restaurants, and other local locations. A person then takes a tag from the tree, purchases the necessities requested, puts the tag back on the presents, and returns it to the location. All of the gifts are then collected from the locations, checked to make sure the presents are what was requested, and then given to the needy at Christmas parties or at the nursing home location with volunteers handing out the presents. Volunteers are invited to participate in the collection and presenting. These presents for several hundred people each Christmas are handed on to the individuals in need. The presents collected have not been valued by the ministry as they are passed on and we have not provided any tax deductible receipts for these presents as they are collected through the trees, churches or at local businesses. It is, however, a large project with many people giving.

In addition to speaking to the civic organizations and churches, the ministry sends out letters to local businesses requesting monetary donations since the ministry does not collect all the presents for all the individuals through the local churches, civic organizations, and gift trees. Monetary contributions are and have been included in the total amounts.

The collection of Christmas presents is the largest single project of the year but throughout the year volunteers visit these individuals in the nursing homes and minister to them. Also there is a ministry to underprivileged children in the projects in three (3) rural counties in South Carolina. Money collected goes directly to support this ministry which works with approximately 150 to 250 underprivileged children on a regular basis and more on different occasions. Volunteers give up their Saturdays to minister to these underprivileged children.

No monetary contributions go to overhead, other than nominal office supplies and gas for the ministry's van while used for ministry purposes, and absolutely no salaries or monetary amounts of any kind are given or provided to anyone with the organization or anyone who volunteers with the organization. None of the officers receive any compensation of any kind. All work is staffed by volunteers who do not receive anything of value for their services other than the reward of helping those in need.
