990EZ Line 20: Included on line 20 is an "other change in net assets" reflecting a decrease of \$1,360,000. This decrease is a reduction in valuation of a single asset, a warehouse building located in Walhalla, SC. When donated to the Ministry on 12/22/2005, the certified appraisal report reflected a value of \$ 1,700,000, and that value was entered on the books of Teleios Ministry to reflect the market value. Given the economic downturn, particularly as applicable to aging textile manufacturing facilities such as this property, we understood that the value of the property has declined. Therefore, we engaged a commercial appraiser to provide a more reasonable estimate of value in order that our accounts and fund balance would not be overstated.
