ADVOCACY and TECHNICAL ASSISTANCE: Cities and towns work together to support a strong municipal legislative agenda and to advocate the role of strong cities as a critical part of the state's competitiveness. The Association produces a variety of information tools that support hometown voices in their efforts to communicate with residents, business leaders, the news media and policy makers. These efforts include: Hometown SC, Achievement Awards, lobbying efforts, Hometown SC Legislative Action Day, Hometown Connection and various types of technical assistance. In addition, the Association's Risk Management Services (RMS) staff helps program members build effective safety and health programs to lower their insurance costs. The Association sponsors training and education opportunities through general and specialized interest meetings, training institutes, communications/publications, a field service program and sponsorship of ten affiliate groups. In 2009, these opportunities included:

Annual Meeting: In 2009, 592 municipal officials from 122 cities and towns registered for this meeting which brings municipal officials together for training, networking and discussing issues of common interest. Officials heard from nationally known speakers, participated in sessions, and learned about new technology and developments in local government.

Municipal Elected Officials Institute of Government: Offers specialized training for elected officials to increase their understanding of local government operations. Classes are held three times annually by satellite and in Columbia the day before the Association's legislative conference (see Hometown SC Legislative Action Day below). During the 2009-2010 training year, 450 elected officials attended one or more of the training sessions with 56 elected officials graduating from the program.

Municipal Clerks and Treasurers Institute: Provides specialized training for municipal employees serving in the clerk/treasurer profession. Topics include financial management, records management, election administration, conducting public meetings, HR management, municipal law and management skills. During 2009, 74 registrants attended the semi-annual training sessions with 5 current year graduates.

Local Government Planning and Zoning Officials Orientation Training: Provides training facilitators and resource materials to meet the six hour orientation training requirement required by the SC Comprehensive Planning Act for new local government planning and zoning officials. The Association recently completed an extensive revision of the training materials to allow facilitators greater flexibility to incorporate local examples for discussion. The resource materials are

approved by the State Advisory Committee on Educational Requirements. Planning and zoning officials completing the training are awarded certificates by the Association.

SC Local Government Management Training Program: This program is designed for city and county managers/administrators and assistants new to the profession or new to the state of South Carolina. This new program is a collaborative effort of the Association, the SC City and County Management Association, the University of South Carolina's Institute for Public Service and Policy Research, and the SC Association of County Managers, Administrators and Supervisors. Offered quarterly, each training session provides the foundation for a specific subject area combined with case studies and/or panel discussions. Session topics include public budgeting, overview of South Carolina local government, financial management, working effectively with council, and employment law and human resource management.

Main Street South Carolina: Follows National Main Street's Four Point Approach--Organization, Promotion, Design and Economic Restructuring--to help members revitalize downtowns into vibrant centers of commerce and community. The Main Street SC program honors exceptional accomplishments in restoring downtowns and neighborhood commercial districts through its Main Street SC Inspiration Awards. Twelve communities participated in 2009.

Municipal Association of South Carolina Website: In July of 2009, the Association relaunched its website, www.masc.sc, with new features and a fresh look. The site has more than 800 pages and provides access to more than 1,500 documents, presentations and links. A powerful search engine and resource library are also available to help users navigate to specific information of interest.

Field Services: Two field service managers (assigned regionally) visit municipal officials to help address issues of local concern. The identification and resolution of minor challenges can often prevent them from growing into major problems. Field service managers are available, at the request of the municipality, to provide hands-on technical assistance. Over the past year, the field service managers made more than 600 visits to SC cities and towns.

Sponsored Affiliates: The Association supports 10 affiliate organizations to provide training and networking for a variety of local government roles. In addition to providing traditional face-to-face learning and networking opportunities, each affiliate association has a listserve for members to share best practices, experiences and specific questions related to their profession. These affiliate groups offered 23 conferences and special programs during 2009. A brief description of the respective purposes of each affiliate group and their 2009 membership base is provided below:

Municipal Court Administration Association (MCAA): Offers training to court administrators, clerks of court, municipal judges and other city/town employees involved in court administration. MCAA members share ideas to make the business of court administration more efficient. 2009 membership base: 221.

Municipal Technology Association of SC (MTASC): Promotes the effective use of technology by municipalities. Through a partnership with the Association and the UNC-Chapel Hill School of Government, MTASC developed the SC Local Government Information Technology Education and Certification Program. This 10-month program, begun in 2008, assesses and addresses some of the most critical issues facing IT leadership in local government. In June 2009, 19 graduates of the program achieved the nationally recognized designation of Certified Government Chief Information Officer. 2009 membership base: 95.

SC Association of Municipal Power Systems (SCAMPS): This group was originally formed to support one another during times of disaster. While mutual aid is still the main focus of SCAMPS, this affiliate expanded their scope to include legislative initiatives and training for electrical personnel such as lineman safety training. Membership includes all 21 electric utilities in South Carolina.

SC Association of Storm Water Managers (SCASM): Offers quarterly training on stormwater management policies and best practices. 2009 membership base: 165.

SC Business Licensing Officials Association (SCBLOA): Promotes best practices for administering and enforcing the local business and professional license tax through training sessions and the professional designations of Accreditation in Business Licensing (ABL) and Masters in Business Licensing (MBL). During the most recent training year, 8 business licensing professionals received the ABL designation, and 3 received the MBL designation. 2009 membership base: 336.

SC Community Development Association (SCDDA): Promotes economic and community development, provides educational forums to address needs and problems of communities, encourages cooperation and coordination between members and other organizations, and sponsors activities to enhance members' professional performance. 2009 membership base: 136 (representing state, local and private entities).

SC Municipal Attorneys Association (SCMAA): Provides an annual training session for municipal attorneys. Training is approved by the SC Bar for continuing education credits. There is no membership for this affiliate group. The 2009 annual meeting was attended by 93 attorneys.

Municipal Finance Officers, Clerks and Treasurers Association (MFOCTA): Offers training programs covering the wide range of responsibilities of finance officers, clerks and treasurers. This affiliate group co-sponsors the Municipal Clerks and Treasurers Institute. 2009 membership base: 224.

Municipal Human Resources Association (MHRA): Promotes sound human resources administration and encourages innovative programs. Training programs are designed to provide information and the opportunity for exchange of ideas. 2009 membership base: 210.

SC Utility Billing Association (SCUBA): Provides training on billing, collection and customer service of municipal utility systems. 2009 membership base: 165.

Cities and towns work together to support a strong municipal legislative agenda and to advocate the role of strong cities as a critical part of the state's competitiveness. The Association produces a variety of information tools that support hometown voices in their efforts to communicate with residents, business leaders, the news media and policy makers.

These efforts include:

Hometown SC: The Association's long-range awareness building initiative to communicate with one voice the value of cities and towns, build relationships with community leaders and encourage support of cities' role in the state's economic competitiveness. This initiative encourages city leaders to speak with one voice about the value of cities and towns through the Association's legislative agenda, media outreach and the "Cities Mean Business" campaign. This campaign encourages new and stronger collaboration between local elected leaders and their business leaders. An online toolkit of resources gives members templates to integrate this campaign into their own hometown efforts.

The Association has partnered with SC Biz magazine, a statewide business publication, to publish a semi-annual magazine called **Cities Mean Business** to spotlight how strong cities are important contributors to the state's economic success. Targeted to business leaders and policy makers statewide, the magazine has a circulation of 15,000 readers and features stories about city-led initiatives to boost the local and regional economy.

Municipal News and Daily News Clips: Municipal News is a weekly electronic newsletter highlighting articles, editorials and other news items. It focuses on legislative top priority issues and spotlights local stories illustrating the value of South Carolina cities and towns. The daily news clips are a quick "at a glance" e-mail with links to news stories of municipal interest around the state.

Achievement Awards: This program recognizes successful and innovative municipal projects that improve the quality of life for residents and add value to the community by establishing partnerships and building community support. The 2009 program received entries from 32 municipalities.

The Association's legislative initiatives support South Carolina hometowns and the value they bring to the state. The Association's legislative agenda focuses on issues that promote economic growth, enhance a positive quality of life, and encourage local accountability and fiscal responsibility. Legislative efforts include:

Lobbying Efforts: Each year, the board of directors, with recommendations from the Association's legislative committee, identifies the Association's legislative priorities. The Association seeks out partnerships and coalitions to support legislation that reflects these priorities. The Association staff monitors all proposed bills affecting municipalities' ability to provide services to their residents and discusses with legislators their impact on South Carolina's hometowns. The Association also tracks federal legislation through the National League of Cities. During the legislative session, a weekly report, *From the Dome to Your Home*, is e-mailed to members to recap the week's major bills and preview upcoming week's activities. Municipal leaders can also keep up with progress of bills through an online monitoring system updated daily by Association staff. During the 2009-2010 Legislative Session, the Association staff tracked 794 bills.

Hometown SC Legislative Action Day: This annual meeting gives municipal officials the chance to learn about legislative issues affecting municipalities and to meet with members of the South Carolina General Assembly. The 2009 meeting was attended by 465 municipal officials representing 135 cities.

Hometown Connection: This program brings municipal officials to Columbia each month during the legislative session giving them the opportunity to talk with their legislators about the local impact of State House actions. The Association staff briefs the visiting officials on pending legislation affecting municipal government. The municipal officials then meet with their legislators, attend committee meetings and listen to floor debates.

Regional Advocacy Meetings: Each fall the Association staff goes on the road to conduct a series of regional advocacy meetings. In 2009, Association staff visited 10 locations and met with more than 300 municipal officials to talk about the upcoming legislative session, develop strategies and gather input on issues important to cities and towns around the state.

Technical Assistance: The Association also provided for professional services from independent contractors to aid cities in financial crisis. Repayment for these services is based on ability to pay. Results for 2009 were essentially breakeven with the Association incurring expenses of \$622,072 and receiving reimbursement for \$621,944.

Part III Line 4c-Risk Management and Insurance Services: Expenses: \$1,890,566 Revenues: \$1,961,337

The Association manages three self-funded insurance programs, an insurance agency and an OPEB trust. Services include: workers compensation insurance, health insurance, property and liability insurance, supplemental insurance and other retiree benefits trust. These products are provided within separate related companies (See Schedule R) with the management of the programs provided by the Association. Each program has a board of trustees composed of representatives from the programs' members. The boards are responsible for policy direction. In addition, the Association's Risk Management Services (RMS) staff helps program members build effective safety and health programs to lower their insurance costs. RMS also assists members through written programs/standards, audits and inspections, technical assistance, training sessions, a video library and newsletter. Information on the individual programs is provided below:

SC Local Government Assurance Group (SCLGAG): This group, formed in 1981, provides medical, dental, vision and disability coverage as well as care management. SCLGAG offers traditional plan options, two health reimbursement account options and a health savings account option. Wellness/fitness one-on-one consultations are also offered to assist members in setting up city-sponsored wellness and fitness programs for their employees. Members at 12/31/2009: 90.

SC Municipal Insurance Trust (SCMIT): Formed in 1984, the Trust provides workers' compensation coverage. Law enforcement and fire department members of SCMIT are eligible for reimbursement programs to cover the purchase of soft body armor, protective gear and other safety equipment. SCMIT has added a public works grant program to fund work-zone safety equipment. The program awarded approximately \$150,000 through its three grant programs. SCMIT also provides numerous services to manage risk and reduce the number and size of claims. Members at 12/31/2009: 102.

SC Municipal Insurance and Risk Financing Fund (SCMIRF): Formed in 1990, this program provides all lines of property and casualty coverage including tort liability, law enforcement liability, public officials' liability, and property and automobile coverage. Law enforcement members of SCMIRF are eligible for reimbursement programs to cover the purchase of law enforcement technology. SCMIRF has recently brought its claim processing in-house instead of contracting with a third-party provider. This will provide long-term member benefits from enhanced, timely reporting and more control over the adjustment process. SCMIRF provides programs designed to reduce claims volume and size which is the key to members managing their long term insurance costs and provides a Labor Hotline for members to receive free legal advice on labor issues. Members at 12/31/2009: 82.

In addition to the above three self-funded insurance programs, the Association offers a GASB 45 compliant trust for pre-funding retirement obligations, other than pensions, and an insurance agency to offer municipal employees voluntary supplemental insurance products.

South Carolina Other Retirement Benefits Employer Trust (SC ORBET): The trust allows member municipalities to lower costs by taking advantage of group rates for actuarial services and earn higher rates of return by pooling funds. Members at 12/31/2009: 29.

Municipal Insurance Services (MIS): Using a "best of breed" approach, MIS offers whole and term life, dental, cancer, accident, critical illness, vision and short-term disability as voluntary supplemental insurance products to municipal employees at the lowest cost possible. Members at 12/31/2009: 51.

The Association contracts with the municipalities of South Carolina to collect certain business license taxes and delinquent debts on their behalf. The four programs described below provide for centralized and efficient collection efforts for participating municipalities. Other Program Services Revenue also includes \$516,892 in member dues and \$83,405 related to information technology.

Insurance Tax Collection Program: Centralizes the licensing procedures for insurance companies and standardizes the collection rates and dates. In 2009, \$121.8 million was collected in current and delinquent business license taxes from insurance companies. \$118.5 million was disbursed to 265 participating municipalities.

Telecommunications Tax Collection Program: Centralizes the licensing procedures for telecommunications companies and standardizes the collection rates and dates. In 2009, \$14.3 million was collected from telecommunications companies. \$13.7 million was disbursed to 259 participating municipalities.

Broker Tax Collection Program: Insurance companies not licensed to directly sell policies in the state provide coverage through South Carolina licensed brokers. These brokers are required to pay a tax to municipalities. In 2009, \$10.1 million was collected from licensed insurance brokers. \$9.6 million was distributed to 265 participating municipalities.

Setoff Debt Collection Program: Local governments can make claims against an individual's state income tax refund to collect for owed debts such as utility bills, taxes, court fines, etc. The Association acts as a conduit for participants to collect on these debts by coordinating information sent to SC Department of Revenue. In 2009, the Association received \$3.6 million in checks from SC Department of Revenue and disbursed \$3.2 million to 162 program participants.

The Association's by-laws establish an Executive Committee consisting of the President who shall act as the Chairman of the Executive Committee, the First Vice President, the Second Vice President, the Third Vice President, the immediate Past President and the Executive Director.

The Executive Committee is empowered to act in general to carry out any of the functions of the Board of Directors that may be necessary between meetings of the Board of Directors except those duties required by state law or by the bylaws to be performed at the annual meeting.

Part VI Line 2: Family or Business Relationships

Two board members of the Association are brothers-in-law. The Association has reviewed the relationship and waived the conflict of interest because it believes the relationship is unlikely to affect their ability to act in the best interests of the Association.

Part VI Line 7a: Election of Governing Body

The membership elects all board members and officers, other than the Executive Director, at the annual meeting. Any official of a member city is eligible as a delegate. Each member municipality has one vote, which shall be the majority expression of the delegates from that municipality. Twenty member municipalities must be present to constitute a quorum at any meeting of the Association. Board member terms are three years, with elections on a staggered term basis. Officer terms are one year. As vacancies arise, an interim member is appointed by the board and then voted on by membership at the next annual meeting.

The Executive Committee is the only committee that has the authority to act on behalf of the board. All decisions made by this committee are ratified in a full board meeting, therefore no separate minutes are maintained.

Part VI Line 10a-10b Affiliate Organizations

The Association has what is calls affiliate organizations (see also discussion of affiliate groups in Part III Line 4a above). These are typically groups of employees of member municipalities with common training needs. Each group elects its own board and determines their own training needs, etc. Although they elect their own board, they are ultimately governed by the Association's board; required to keep their activities within the Association's mission and follow all MASC policies and procedures. Each affiliate group has a written service agreement with the Association and a staff member is assigned to help with content development, meeting planning, administrative functions as well as to provide compliance oversight. In accordance with the Association by-laws, the Board of Directors determines the compensation of the Executive Director. Each Board member completes an annual review of the Executive Director's performance. These reviews are compiled by an independent third party and submitted to the compensation committee. The compensation committee reviews the Executive Director's performance and other comparative salary information from like organizations. This committee makes a recommendation to the full Board. Although the committee and the Board may meet with staff during this process, including the Executive Director, deliberations and final decisions are made with no staff members present. All final decisions concerning the Executive Director's compensation are fully documented.

The Association has an independent compensation consultant perform a salary study periodically to determine suggested salary ranges for all employees including the Executive Director. The salary ranges are approved by the Board of Directors. Between salary studies, the ranges are increased by an annual cost of living percentage. The cost of living increase is approved by the Board of Directors. The Executive Director sets compensation for all other employees of the Association (including other officers and key employees) based on performance and approved salary ranges.
