Scholarships & other programs: The Foundation is the leading organization for awarding scholarships to students and risk professionals. Since 1980, the Foundation has awarded nearly \$4M in scholarships, with \$183K in scholarships being granted in 2009. FM Global Course Development Grants totaling \$100K were awarded to the University of Hartford and Virginia Commonwealth University with \$50K each for the development of undergraduate course modules and a graduate loss prevention course curriculum for students studying risk management and insurance. The RIMS ERM grant of \$50K was used to create professional development programs that enable risk managers to perform more effectively in the workplace and to add value in their organizations. The focus of the programs developed was having risk professionals acquire the necessary knowledge, skills, and tools in enterprise risk management.

Student involvement programs: This program is designed to provide students with a meaningful internship experience and maximum exposure to risk management and the issues facing today's practitioners.
