We continue to fund our Conversation Cafe, a one-on-one empowerment program for women and mentors to help women move up to better jobs and/or further their education

Provided community development funds to Peach and Justice Support Group, BAND, Inc. and The Frances Morris Legacy Fund. Continue the work of th Valley Interfaith Promise, which serves homeless families. As part of our community education program, we published the Easter Meditations, a series of thought provoking essays. The Frances Morris Legacy Fund partners with various local groups to provide counseling and support for individuals who are victims of sexual abuse and incest.

Continued to fund the development of the Youth Leadership Project (INFUSION) which engages 15 high school students in various activities in social ministries, to include various religious reflections and studies, hands on servant leadership in the community, and started a reading program in the Beallwood Area.
