Education and ConservationAward-winning Education Programs make Zoo Atlanta an unusual hybrid in the city Over 100,000 participants benefited from the wide variety of programs, including several new additions Summer Safari Quest, a new day camp experience for 6th to 9th graders, presented new opportunities for older kids to explore weightier issues in conservation and ecology Deluxe Family NightCrawlers debuted with Tusks at Dusk in summer 2009 By popular demand, Deluxe NightCrawlers were broadened to include two additional programs, Reptile Feeding Frenzy and the consistently sold-out Pure PANDAmonium A proud supporter of the SPARKS (Supporting Parents in Advocacy, Reform and Knowledge of Science) Program, Zoo Atlanta hosted four parent-driven workshops and two public SPARKS Fairs New options for college students and undergraduate classes included self-guided field trips and research passes Self-guided field trips now offer an upgrade option to include a lecture by a Zoo curator, veterinarian or educator As a complement to The Mabel Dorn Reeder Foundation Conservation Endowment Fund established in 2008, Zoo Atlanta worked with the Foundation again in early 2009 to establish The Mabel Dorn Reeder Foundation Chair of Conservation Research Endowed with a generous commitment of \$1 million, the position is focused on the Zoo's conservation centers of excellence primates, giant pandas, and amphibians and reptiles Among the projects earmarked for support by The Mabel Dorn Reeder Conservation Fund in 2009 was an ambitious head-start initiative for endangered indigo snakes Now underway, the project will reinforce indigo snake populations in the Conecuh National Forest through capture and re-release of gravid females, with plans to rear and reintroduce their offspring to the wild The program is managed in partnership with the Georgia Department of Natural Resources, Alabama Department of Conservation and Natural Resources and Auburn University

the visitor experience and public eventsThe 2009 Visitor Survey Report conducted by an outside agency found that Zoo Atlanta consistently ranked at or above a competitive benchmark average, including overall satisfaction, employee courtesy, cleanliness, admission value, educational and entertainment experience, and food service and gift shop courtesy Most significantly, the Zoo's Net Promoter Score of 96 - the percentage of guests who would recommend the Zoo to others - outperformed the benchmark average of 82 among several other leading U S zoos The largest experience of its kind in the Southeast, Boundless Budgies A Parakeet Adventure opened a colorful new world where the wildlife came closer than ever before Eager to interact with the aviary's more than 500 residents, an enthusiastic public helped feed the zoo's new residents, going through seed sticks by the tens of thousands during the course of the year In August, Zoo Atlanta's latest and most innovative vehicle, USTREAM TV, introduced biweekly interactive keeper talks presenting exclusive behind-the-scenes looks at animal care throughout the Zoo The annual City of Atlanta and Fulton County Family Days, offering free admission to residents and employees of Atlanta and Fulton County, attracted more than 10,000 guests on August 8 and 9 Some 200 local children received free dental exams on Zoo grounds through partnership with the Colgate Bright Smiles Bright Futures Dental Program

The Animal Collection and Success with Endangered SpeciesAmphibians The world's first captive-born evergreen toad was joined by hundreds of others Scores of enclosures were transformed into ad-hoc nurseries for the housefly-sized newborns This success has since allowed several AZA institutions to begin exhibiting this little-known Central American species Reptiles While it wasn't the Zoo's first success with Pan's box turtles, the successful hatching of seven in 2009 was an institutional record Endemic to China, the critically endangered species faces extinction due to over-harvesting for food Reptile species born in 2009 African pancake tortoise, Mexican box turtle, Mexican cantil, radiated tortoise Mammals Warthog pair Vern and Shirley welcomed their second litter on April 14, 2009 Born smaller and weaker than their siblings, two of the four piglets were hand-reared by Zoo staff, while their brothers charmed new fans on the Zoo's African Plains The naked mole rat queen finally had a chance to show her maternal side with the birth of her first surviving litter In October, the ruler of the Zoo's strangest society made a triumphant return to her subterranean court with 10 thriving juveniles Mammals born in 2009 black-and-white-ruffed lemurs, red kangaroo Birds2009 was an extraordinary year for birds A wreathed hornbill chick hatched in May - a coup for Zoo Atlanta, as their unusual and complex reproductive behavior makes this species highly difficult to breed Just days after a special flight from Washington, D C , two kor bustard eggs hatched in August Zoo staff traveled to Smithsonian's National Zoo to retrieve the eggs, which the Species Survival Plan had recommended be hatched and raised at Zoo Atlanta Other birds hatched at Zoo Atlanta in 2009 included budgengars, Chilean flamingos, Madagascar teal, Palawan peacock pheasant, speckled pigeons, superb starlings, violaceous turacos, white-crested laughing thrushes, and white-faced whistling ducks New to the ZooIn addition to the successful breeding and births at the Zoo, more than 100 animals made new homes at Zoo Atlanta from January to December Mammals Angolan colobus monkeys, drill, Geoffroy's tamarrns, golden lion tamarin, Hoffman's two-toed sloth and Schmidt's guenons, Birds Bali mynah, blue-crowned pigeon, Gambel's quail, Lady Amherst's pheasant, northern helmeted currasow, racquet-tailed rollers, red-capped cardinals, spotted dikkop, taveta golden weavers, Victoria crowned pigeon and vulturine guineaowl, Reptiles Arakan forest turtle, Aruba Island rattlesnake, Chaco tortoises, cottonmouth, eastern musk turtles, emerald tree boas, green tree pythons, Guatemalan beaded lizard, impressed tortoises, king cobra, McCord's box turtle, pygmy rattlesnake, timber rattlesnake and Woma python, Amphibians American bullfrogs, lemur leaf frog, orange eyed tree frog, splendid leaf frog, and Invertebrates giant African millipedes and Madagascar hissing cockroaches
