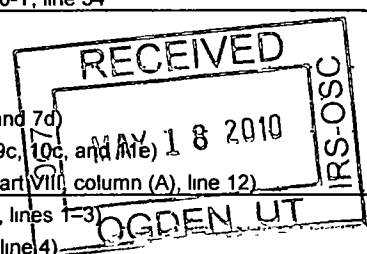

ACCOMPLISHMENTS AND ORGANIZATION'S PRIMARY
EXEMPT PURPOSE

The major benefit received by the members of GAP Group, Inc. is the ongoing development and maintenance of assessment software necessary to the smooth operation of their respective offices. As statutes and regulations change, attendant changes must be made in the software to assure compliance with the law. GAP Group assures that these changes are made in a timely fashion. This benefit is available to any user of the software, regardless of membership.

Another benefit of membership would be in participating in the establishment of priorities in enhancements and modifications of the existing software. Since GAP Group Inc. pays for these contracts, obviously selection of what to do is made by the members. The only work not prioritized by GAP Group would be modification required to meet changing statutes that is paid for by the State (i.e. Governor's Emergency Funds). Only members of GAP Group Inc would be surveyed to establish priorities of development.

A third benefit of membership would be "internal support"; members of GAP Group share resources and skills with each other much more regularly than they would with non-members. (This would be partially due to familiarity.)

A potential benefit of membership that was discussed at the last Annual Meeting of the membership would be lower costs to individual counties by combined purchasing of materials and supplies. For example, GAP Group is investigating placing orders for complex forms as a group, and getting the resulting price break for larger purchases. This benefit would be available to members only.

GAP Group is hoping to offer seminars in advanced applications of the GAP Software. These would be free to members, and cost non-members at a rate equal to current costs for attending Georgia Association of Assessing Officers' seminars (\$20.00).
