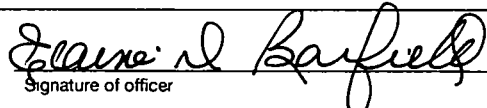

Holy Trinity Parish allows the Trust to use some office space for storing of the Trust books and records. The Trust has its accounting software on the computer owned by the Parish. However, the Trust does reimburse the Parish for any usage of copies or postage by the trust.

As the corpus of the Trust remains modest at this early stage in the life of the Trust, scholarships have been small. The Trust's purpose is to provide scholarship funds to person(s) lay or ordained, who are undertaking a course of study to prepare them for teaching and spreading the Gospel of Christ. Each applicant is considered in light of how well they meet the intent of the Trust's purpose:

Word of the Trust's existence and scholarship program has been spread by letter within the Diocese of Atlanta and to various Episcopal seminaries. It is the intent of the Trust to make itself more widely known as growth of the corpus would permit a larger number of scholarships each year. In 1998 we established a Web page which has increased interest in the Trust.

Each application for a scholarship gets a letter and completes an application form. Annually four members of the Board review the completed applications. The merits of each applicant are discussed in a meeting. The finalist(s) for scholarship(s) is/are recommended to the full Board, which chooses one or more persons; with the number of scholarships available depending on the estimated annual income available from the Trust.
