The Bicycle Recycling Program (BRP), run entirely by volunteers, procures donated or abandoned bikes and restores them to safe and reliable working order. It is a cooperative venture with local social support agencies who distribute the reconditioned bikes to individuals in the Athens community who are underserved by private and public transportation.

Advocacy and outreach. BikeAthens provided weekly information updates on local, state and national alternative transportation issues via listserv, blog, and website. The organization solicited public input on transportation and planning issues via sub-committees and online surveys, provided mechanisms for the public to comment upon governmental actions via online secure, auto-forwarding forms, raised awareness via administration, sponsorship and/or participation in awareness events such as Multi-Modal Madness, Tour de Farm, Bike to Market days, Bike to Work day, GreenFest, Bike Art Show and an annual gathering of all BikeAthens members.

The Bicycle Education Program provides cyclists the skills and confidence they need to ride safely and legally in traffic or on trails. Coordinated through the League of American Bicyclists, the BikeAthens organization has trained and certified League Cycling Instructors set up to provide basic cycling safety courses, called Road 1 and Kids 1, to local individuals. The program also includes practice rides (Courteous Mass) a monthly, casually-paced bike ride of 5-6 miles around town.
