| | See Schedule O Expenses \$711,776, Grants \$711,776Thompson Cancer Survival Center Foundation (TCSC Foundation) provides funding for the formal affiliation agreement between Thompson Cancer Survival Center (TCSC) and the M D Anderson Physician's Network (MDA) Fifty-one physicians have been credentialed to participate in the affiliation and 24 patients were referred from TCSC for care by MDA Additionally, 24 peer-to-peer phone calls were conducted at the request of our physicians to seek advice from the staff and faculty of MDA on a particular patient or case at TCSC There were also multiple educational opportunities for nurses, physicians and other healthcare workers associated with this affiliation TCSC hosted 24 multidisciplinary video conferences focused on site-specific diseases with discussions among physicians across the country CME and CNE credits were available for each of these conferences, and any credentialed physician was able to present cases Additionally, three guideline update video conferences were offered featuring MDA physicians as well as two educational series video conferences, all with CME and CNE availability The affiliation affirms Thompson Cancer Survival Center's exceptional quality of patient care, and gives physicians and patients of TCSC access to the University of Texas M D Anderson Cancer Center's evidence-based guidelines and treatment plans, multidisciplinary planning, conferences, concordance studies and other resources coordinated by MDA The knowledge TCSC gains through MDA will help prevent, diagnose and treat cancer more effectively |

| | See Schedule O Expenses \$361,909, Grants \$361,909In 2009, the Social Services Department of TCSC reported 970 new patients and 2,737 follow-up patients Additionally, 736 new patients and 1,908 follow-up patients were provided with dietician counseling and education Thompson Cares, a fund to assist patients in cnsis situations, provided emergency funding for 315 patients to aid with food, shelter, transportation and other needs The Social Services Department includes a Genetics Clinic staffed by 2 licensed and certified genetic counselors who provide breast cancer and hereditary cancer risk assessments and genetic testing In 2009, the Genetics Clinic counseled 253 patients, including 163 who pursued genetic testing Of those, 12% tested positive for a hereditary cancer syndrome Patients were able to make informed decisions regarding their medical management based on this testing and counseling The social services grant provides all TCSC patients with psychosocial support services including nutritional, spiritual, emotional and financial needs which arise during the course of cancer treatment In addition, genetic counseling is provided These services are currently non-billable, yet provide a vital piece of a comprehensive patient plan of care which is critical to successful treatment |

Board members' conflicts of interests are dealt with in the corporate bylaws and board members are required to complete and sign a conflict of interest questionnaire on an annual basis. The Integrity Compliance Office of the parent company maintains records that contain conflict of interest information obtained from board members, officers and employees. These records are available to be queried prior to engaging in business transactions. The Integrity Compliance Officer initially reviews all conflict of interest data. Based on this information, the officer determines what conflicts of interest exist at that point in time. Between times when surveys are collected board members are expected to disclose any new conflicts that have arisen that affect pending board decisions. As well, managers and other employees are expected to report conflicts to the Integrity Compliance Officer as they arise. Depending on the nature of the conflict and the circumstances surrounding the conflict and transaction, the Integrity Compliance Officer, Senior Leadership, or the Board of Directors may review the conflict of interest. Where appropriate these bodies may also consult legal counsel. Restrictions imposed on persons with a conflict of interest are determined on a case by case basis. For Covenant Health employees, the Integrity Compliance Officer, in consultation with Senior Leadership at the facility and if necessary executive leadership at Covenant Health determines how to appropriately handle the conflict. Any conflicted board member is expected to excuse himself or herself from voting on matters that give rise to the conflict. |
| Form 990, Part VI, Section B, line 15a | | Base salary for Virginia Morrow, President of Thompson Cancer Survival Center Foundation, SVP of Covenant Health, was established according to an executive salary structure developed by the consultant and approved by Covenant Health leadership. Each salary grade has a minimum, a midpoint, and a maximum. Midpoints are established by the consultant based upon contemporary market data for various positions in a tax exempt health system. Initial salary offers are made by the EVP-Human Resources with review and approval by the CEO. As long as the offer is between the lower and upper levels of the mid range of the approved salary grade, no other oversight is required. However, if the offer exceeds the mid-range, then the EVP-Human Resources in conjunction with the consultant determines reasonable compensation. Annual bonuses are determined according to the performance-based incentive compensation policy and the evaluation of the performance level of each executive. The Executive Leadership Team (comprised of the CEO, CFO, EVP-Human Resources, and EVP-Hospital operations of Covenant Health) determines each bonus award predicated on the performance of the individual on predefined, measurable annual goals. Adjustments to the salary structure and individual executive salary increases reflect information provided by the consultant. An executive's tenure, experience, and performance are also factors utilized in providing salary increases, if any. Salary increases are approved by the Executive Leadership Team. |
