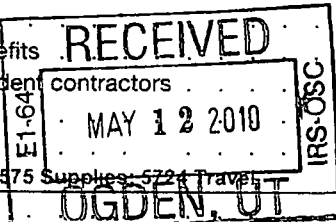



## **A BRIEF REPORT OF THE MINISTRIES OF KERALA CHRISTIAN MISSION IN 2009**

**Praise God for another fruitful year for the ministries of KCM.**

**In 2009 our focus was on training leaders in the local congregations. I am teaching the classes now in Kottayam area and the Lord willing we hope to continue the same in 2010 with the senior preachers teaching classes in other parts of Kerala.**

**The Westchester Indian Christian Church, Yonkers, New York was officially inaugurated on August 15<sup>th</sup>. Reni and I were able to be present at that historic moment with Bro.C.T.Abraham and family. This ministry is growing day by day. We spent 2 months visiting our supporting churches and made a few new contacts for future partnership in the ministry.**

**The Dubai house church is now blessed to have a 2 bedroom apartment (Rented) and has added 4 members during the year.**

**The house church in Qatar was blessed with a temporary meeting place rented from the Anglican Church. I was able to spend 4 days with them in October, leading seminars and worshipping with them. It was encouraging to see the 'lay preachers' ministering so efficiently in a Muslim country. I was blessed more than I could bless them.**

**The Mission projects of our local churches are adding souls in Andhra Pradesh and a new church building was dedicated on November 17<sup>th</sup>, thanks to the generosity of Kerala Churches. Some of our self supporting churches are struggling due to the present financial crisis in some areas, but the Town churches have come forward to support their weaker brethren. This is a great development in the history of our Mission. Praise the Lord.**

**The Serenity Social Welfare project is caring for 90 underprivileged children in their development. There was a drop of 10 students due to resistance from their religious leaders (Muslims) when we introduced Bible studies for them. Yet it is encouraging to see that the majority are willing to study the Bible. Our orphanage, old age home and Ministry to the Blind are doing great services to the community with the love of Jesus Christ.**

**The Mission continues to give Housing Aid, Educational Aid, Medical Aid and Marriage Aid to deserving people. We do appreciate the help from IDES in this respect.**

**The Hospital cares for over 100 patients each day. The Eye Camps give sight to hundreds and continue to reach the people with the love of Christ. The help of FAME is note worthy in this ministry.**

Martin is leading the Youth ministries with a definite goal and Youth camp was well attended. The family camp is led by different senior preachers each year.

Kakkanad English Congregation celebrated their first anniversary on 10 Jan.2010 and it was attended by 79 people. We are able to reach out to young people through the English services at Kottayam and Kakkanad.

The Lord has blessed our family with one more grandchild making the total four, two boys and two girls. Our daughters, Cinu and Cindy are both involved in full time ministries with the Mission. Cinu works with our hospital organizing Medical Camps and Eye Camps and Cindy manages the Serenity Social Welfare Centre for under privileged children. Both sons-in-law are serving the Lord and we are proud of them. My mother has been bed ridden since August 2009 and we request your prayers for her. She has been a great inspiration for me in this ministry.

We are thankful to the Seminary of the Nations and Dr. Steve Hooks for providing quality on going training for our preachers.

All of these are made possible because of your generous gifts. Thanks to all our faithful supporters for your commitment to the cause of Christ, in spite of the recession.

We praise God for His faithfulness and kindness expressed through your gifts.
