During 2009 afterschool, educational, and recreational programs were provided to more than 500 children and youth, aged 5 through 18.

Housing Programs - Eden Village I, a four-month transitional shelter, served

146 women and 290 children in 2009. Eden Village II, a three-month 100 bed emergency shelter for adult women opened in July 2009.

Job Training and Education Programs - The 180 Degree Kitchen trained 60 youth aged 18-24 in a 12-week culinary arts course preparing them for careers in the food industry. City of Refuge operated a second job training program, Glenwood Lanes Bowling Alley, from June 2009 through October 2009.
