Research The ALR engages in active grant making management, working hand-in-hand with investigators to guide and drive the research process Since its inception, the ALR has committed over \$58 million to fund lupus research projects In 2005, the ALR launched a global consortium of lupus researchers Members of the International SLE Genetics (SLEGEN) Consortium pooled their resources and intellects, determined to find the genes responsible for lupus Researchers uncovered robust evidence linking 13 genetic candidates to lupus The three-year project was supported by \$2 5 million in funding from the ALR In 2009, grants totaling \$4 5 million were awarded, of which approximately \$2 4 million was to 6 investigators with promising new avenues of research and approximately \$1 million was renewed funding for 3 investigators In addition, \$1 1 million was awarded to 5 investigators under the ALR's new Genetic Pathways grant mechanism which provides a researcher up to \$350,000 to further the studies begun by the SLEGEN Consortium ALR's unique funding model supports promising research efforts with the goal of improving the lives of people with lupus in the near future Through a competitive peer-review process and an innovative venture-capitalist approach, projects by the ALR aim to translate results from the research bench to the bedside Because the ALR's board of directors funds administrative and fundraising expenses, 100% of all other contributions goes to support lupus research programs like SLEGEN

Scientific Programs The ALR encourages cross-sector and cross-discipline partnerships to foster an innovative research environment In 2009, there were collaborative meetings funded by the ALR where researchers were encouraged to exchange ideas and help the ALR target new research opportunities This included Scientific Advisory Board meetings, out of which came support for continuing the ALR's Target Identification in Lupus grant program, the Genetic Pathways grant mechanism, continue support for the SLE Genetics Consortium and encouraging partnerships among investigators, pharmaceutical and biotech companies and for clinical trials ALR sponsored a unique meeting in 2009 which gathered some of the most informed scientists, rheumatologists and other clinical and research experts from around the world to examine the science behind past and current clinical trials in lupus and data from pre-clinical studies investigating promising new agents Eight pharmaceutical and biotech companies shared their data during presentations to the group All of the companies present have been working on developing potential new treatments for lupus The participants drilled down into the shared data to see what they could learn about what is working and what is not in these studies and to identify clues to be explored in future studies

Public Policy The main goals of the ALR's public policy program are to educate Members of Congress and the Administration about the importance of funding lupus research, to increase federal funding for lupus research by increasing overall National Institutes of Health (NIH) funds, and to secure additional funding for lupus research through other key federal agencies including the Veterans Administration and Department of Defense Through the ALR's public policy program efforts, funding for lupus research has been obtained under the Department of Defense Peer Reviewed Medical Research Program This is a \$50 million competitive research grant program Only those diseases listed in the Defense Appropriations Committee Report are eligible to receive funding ALR was responsible for persuading Congress to include lupus on this very competitive list the past five years The ALR is pleased to report that lupus has again been listed under the Department of Defense Peer Reviewed Medical Research Program (PRMRP) in the House FY 2009 Military Quality of Life Appropriations bill Through the ALR's continued efforts to include lupus on the list of diseases under the PRMRP in the Defense Appropriations bills, the DOD has awarded over \$8 million to lupus researchers since 2004
