APPROXIMATELY 150 HEALTHCARE PROFESSIONALS WITH AN INTEREST IN GENETICS ATTENDED. FORTY-NINE PLATFORM AND SEVENTEEN POSTER PRESENTATIONS WERE MADE COVERING CURRENT ISSUES IN ALL AREAS OF GENETICS: MOLECULAR GENETICS, CYTOGENETICS, BIOCHEMICAL GENETICS, AND CLINICAL GENETICS. HIGHLIGHTS INCLUDED A CLINICAL OVERVIEW OF INHERITED DISORDER OF GLYCOSYLATION, PKU GENE THERAPY, AND CLINICAL GENETIC ASSESSMENT OF THE ETIOLOGY OF AUTISM. THE CONSUMER ALLIANCE GROUP INCLUDED AN INTRODUCTION TO NBS CONNECT, A PATIENT REGISTRY FOR ALL METABOLIC DISEASES.
