Tallahassee's #1 Auto Lending ProgramOver the past decade, Florida Commerce has earned the title of Tallahassee's number one auto lender year after year. This title has been consistently earned because the credit union offers a range of auto loan choices for almost every budget and credit level. Florida Commerce's flexible terms and competitive rates allow members to purchase the vehicle they need at a monthly payment they can afford. Over 9,000 members currently enjoy the most consumer-friendly auto loan program in the area! In 2009, Florida Commerce established an indirect lending program for auto lending to take advantage of FCCU's leadership position in local auto financing and the current economic conditions to increase loan volume and profitability. Total loan volume in 2009 was 164 loans with over 3.2 million in originations.

iLiveFIT! Financial CoachingThe iLiveFIT! (Financially Independent Today) program provides free one-on-one financial coaching to credit union members, along with a reward system for those who reach financial fitness goals. Members enrolled in the iLiveFIT! program receive an initial assessment to review credit reports, retirement and emergency saving, money management, and more. After the initial assessment, members are given a "prescription" guaranteed to improve their iLiveFIT! score. As members show improvement in their financial fitness, they receive rate incentives from the credit union. The more financially FIT a member becomes, the more rewards he/she earns. This program launched in fall of 2008 and by the end of 2009 over 1,600 members had enrolled in the program. With the help of the iLiveFIT! program, the weLiveFIT! Challenge was implemented. Seven local families followed a "prescription" plan to meet their financial goals. The seven families met regularly with Florida Commerce financial fitness coaches who tracked their progress on the road to getting FIT, meaning Financially Independent Today. The household with the most financial improvement at the end of the challenge would emerge as the \$10,000 winner.
