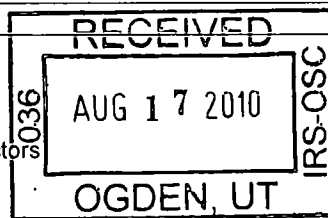

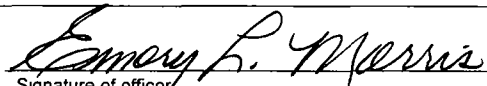
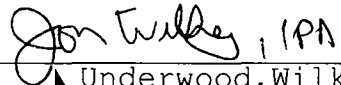

The Chattanooga Scottish Rite Foundation, Valley of Chattanooga, Orient of Tennessee (the "Foundation"), is a Tennessee non-profit corporation holding tax-exempt status pursuant to I.R.C. § 501(c)(3). The Foundation is engaged in charitable activities and has developed a significant working relationship with T. C. Thompson Children's Hospital where the Foundation provides ongoing support for the speech and language center at such hospital. Funds donated by the Foundation are used for both capital and non-capital expenditures, and all are directed to improving the quality of speech and language services provided to young children.

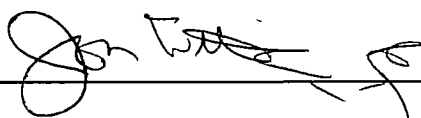
