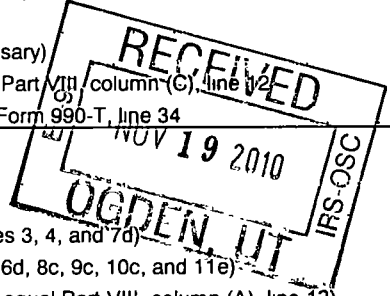

1. **Community Organizing.** Outreach to grassroots organizations; administration of regular meetings including regional advisory board meetings, tri-annual State Board meetings, and an annual membership meeting; leadership development, training, and research to support the Board's projects; maintenance of relationships with statewide media; contact with government bodies on FCAN issues. FCAN maintains ongoing communications with many allied and affiliated organizations.
2. **Public Outreach.** FCAN communicates with members in many ways including email alerts, a web site, a blog, Facebook page, and Twitter feed. FCAN mails updates to donors. FCAN does extensive media work to educate the public on consumer and environmental issues including press releases, media briefings, editorial board meetings, letters to the editor, and op eds. The Florida Consumer Action Network (FCAN) is a non-profit, grassroots, consumer and environmental advocacy organization with offices in Tampa, Fort Lauderdale, and Tallahassee. FCAN's mission is to empower citizens to influence public policy by organizing and educating in areas where consumer voices are underrepresented.

FCAN's goals are to:

- Educate our members and the public on important issues;
- Advocate public policy which improves quality of life;
- Ensure that legislation and regulation results in a fair economic return to the consumer;
- Encourage citizen participation in setting public policy; and,
- Raise adequate funds to maintain a professional staff and meet our organizational goals.

The issues on which FCAN focuses its advocacy change from year to year with input from our members; FCAN's Board of Directors ultimately determines our issue agenda. 2009 issue priorities included:

- Educating the public on health care issues, particularly the need for a national program of affordable, available, accessible health care for everyone. We went door to door, held town hall meetings, and phoned members, talking to citizens and urging them to write Congress.
- Advocating consumer friendly telecommunications policy by monitoring the deregulation of Florida's incumbent local exchange companies and promoting real competition for local phone service.
- Organizing homeowners for insurance reforms to protect policyholders through available and affordable insurance, including working to create an independent Florida Insurance Consumer Advocate and forming an Insurance Consumer Coalition.
- Fighting for Environmental Protection, including defending "Citizen Standing" provisions of the Florida Environmental Protection Act and cleaning up Florida's natural environment
- Public education supporting safe drinking water, food safety, pesticide reform, the cost of takings, and other national environmental issues.
- Working to preserve the civil justice system and the rights of citizens to seek redress in the courts before a jury of their peers when damaged.
- Defending Florida's public campaign finance laws for statewide candidates and working for passage of the Florida Clean Elections act, a campaign finance reform bill.
- Organizing citizen groups to protect Cypress Creek Preserve, a vital headwater of the Hillsborough River system. As part of the Cypress Creek Campaign, FCAN is working to create a regional transportation system that will take the place of roads like the one proposed through the Cypress Creek Preserve.
- Advocating for cleanup of Florida's dirty power plants including the Crystal River power plant and use of clean renewable energy resources and greater energy efficiency. FCAN opposes construction of new nuclear plants and especially opposed advanced billing of consumers for those plants, since we believe they may never be needed or built.
- Carrying out Civic Engagement activities targeting low income, minority voters, and other underrepresented groups. These activities included voter registration and organizer training.
