LOVE A CHILD, A CHRISTIAN BASED HUMANITARIAN RELIEF AGENCY, WAS ESTABLISHED IN 1985 TO CARRY OUT CHRISTIAN MISSIONARY WORK IN HAITI GUIDED BY BIBLICAL PRINCIPLES OF EVANGELISM AND LOVE, LOVE A CHILD WANTS TO DEMONSTRATE THE LOVE OF CHRIST BY FOCUSING ON POOR CHILDREN AND FAMILIES OF HAITI, OPERATING AN ORPHANAGE, MANY SCHOOLS, AND A MEDICAL AND MALNUTRITION CLINIC, AND SERVING MORE THAN 40,000 HAITIANS DAILY

Love A Child Orphanage Love A Child continues to operate the 21,500 square ft orphanage in Fond Parisien, recognized by the Health and Education Department of Haiti as among the best in the nation Jesus Healing Center Our program services expanded in March 2009 with the opening of our Jesus Healing Center, medical and malnutrition clinic Since opening in March, we have averaged having 90-100 patients per day, M-F We have seen everything from routine malodies to emergency cases which had to be referred elsewhere We have had to increase our medical staff by adding another physician and three more nurses, and lab personal

Mobile Medical Clinics During 2009, Love A Child conducted mobile medical clinics in remote province areas, treating more than 6,000 children and 2,000 adults for diseases such as malnutrition, malaria, typhoid, bacterial infections, worms, respiratory illnesses, etc In addition, we distributed pallets of vitamins so that children received nutritional supplements and vitamins for malnutrition Love A Child brought in and distributed containers of medical supplies and other humanitarian items to Love A Child clinics, hospitals and other orphanages in Haiti

Feeding Programs Utilizing the new Food Distribution Center, Love A Child handled shipping containers of food and meals, feeding approximately 5,000 children per day through the school programs Also, many families in the school villages are sponsored monthly with food boxes purchased and distributed every two weeks by Love A Child Love A Child supports cooks, drivers, cooking fuel and all associated costs of the feeding programs

Churches and Schools Love A Child founded and maintains fourteen functioning primary schools in Haiti, where we educate and feed more than 5,000 children each day Love A Child employs fourteen School Directors and over two hundred school teachers In addition to the primary schools, adult Education and vocational training classes are held in Fond Parisien and LeTant villages In most of the villages where we have schools, the school building also serves as the church We establish the connection between the church and the school and all our outreach programs by having worship services and Gospel education centered in these buildings Missions Teams Love A Child hosted and conducted missions trips, with groups as large as 16 people going to the mission field for opportunities of temporary service Mission trips usually last a week, and services ranged from remote medical clinics to food distribution, building churches, schools and housing, and Gospel crusades Housing for the Poor In addition to maintaining the "new" village of LeTant, with new block houses and central solar-lighted community area, we completed construction of a block church in LeTant for worship service The church also serves as a class room for children and space for some adult training and education There are constant maintenance and repair works done on houses in some of the villagers Fish Farm and Training School Love A Child's Tilapia Fish Farm Project and Training School continued to expand in 2009 The fish farm not only provides fresh fish for the orphanage and Fond Parisien school, but it allows other local organizations to learn about fish farming Several young men from the orphanage and from other organizations learned Fish Farming, enabling them to start or operate other fish farm projects In addition, the Joseph's Carpentry shop is a training center for wood working and carpentry skills for the near-by village Jesus Healing Center One of our greatest Blessings so far has been the opening and dedication of our Jesus Healing Center, a two-story medical clinic in Fond Parisien, complete with diagnostics lab, treatment rooms, pharmacy, and on-staff nurses and doctors This clinic now serves the surrounding villages and also over 1,500 school children in the Fond Parisien Schools The medical clinic will also have a Malnutrition Center for infants and small children who are severely malnourished Christian Radio Station 103.5 FM This outreach program broadcasts the Gospel and social and health education programming on 103.5 FM nearly 12 hours a day, providing a Christian message as an alternative to the voodoo message which had dominated the region before Love A Child arrived Thousands of solar powered hand-held radios have been distributed in the region by Love A Child The radios are pre-set to receive only the Love A Child broadcasts where they can hear weather broadcasts, Gospel messages, health and hygiene topics, all in French, Creole and English Food Distribution Center This two-story 15,000 square foot building in Fond Parisien provides a secure warehouse and distribution center for all the food used in our feeding programs, as well as being a depot for In-Kind gifts and donations, such as health and beauty aids, clothes, etc Missionary / Medical Housing During 2009, the three on-site Missionary houses were maintained, housing many visiting missionaries while they served in Haiti Full-time missionaries, Bob and Carole Stufflebeam have even added landscaping and a vegetable gardens Construction began on a new power generator house and an additional doctor and medical staff housing unit near the Jesus Healing Center Water Projects In 2009, Love A Child continued to maintain and repair local wells and pumps for the villages of Fond Parisien and LeTant, providing clean water for the villages Other Outreaches Love A Child also participates in other community outreaches such as the distribution and sharing of In-Kind donations with other hospitals, orphanages and organizations in Haiti In 2009, Love A Child shipped containers of food, books and educational supplies, garden seeds, clothing, medicines, vitamins, new Nike Tee shirts and shoes, clothes and other supplies into Haiti Besides distributing these items to the Love A Child-sponsored villages and families, we were able to share many of these items with other humanitarian organizations working in Haiti
