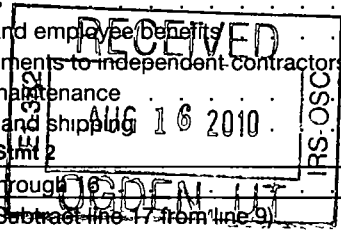

The Community Nutcracker, Inc. is a non-profit organization dedicated to supporting and maintaining the highest quality of artistic vision. In its goal to produce a community sponsored and supported ballet, talented students, professionals and business leaders from the Northeast Florida area work together to produce the annual event.
